RUNNING ORDER

Dogs in the Introduction to Quarry, Junior Earthdog, and Senior Earthdog classes will be run in the order in which their entries are received. Multiple entries by the same owner/handler will be separated to expedite the smooth running of the test. The running order for each class will be posted prior to the start of the class. Dogs not ready to run when called will be moved to the end of the running order. The judge will not wait for late arriving dogs.

Dogs entered in the Master Earthdog class **must** be present on the grounds and answer to roll call at 7:30 AM on the day of the test. Only those dogs present at the roll call will be deemed to be starters, and will be entered in the random drawing for ME Class running. (Ch 1, Sec. 15)

Dogs must be at least 6 months of age. Spayed, neutered, limited registration and ILP dogs of eligible breeds are eligible to enter. Bitches in season shall not be eligible to enter the tests. (Ch 1, Sec. 4).

NOTICE TO EXHIBITORS

The **Northern California Dachshund Club** offers a rosette to each dog who earns a qualifying score.

NCDC "Certified Earthdog" cap will be awarded to each dog that earns a title at the test, please inform test secretary.

Dogs that have earned an AKC Master Earthdog title may enter both Senior & Master classes.

Returned checks do not constitute a valid entry fee. The Test Secretary shall add a \$25.00 collection fee to the amount of each returned check.

Coffee & cake will be available in the morning and a **POT LUCK LUNCH** is planned for both Saturday and Sunday, so please bring something to share.

Wear layered clothing, water-proof boots and bring rain protection. **TEST WILL BE HELD RAIN OR SHINE!**
